York Day Nursery Becomes YORK DAY EARLY LEARNING

On a beautiful summer evening we welcomed dozens of guests to Millbourne Gardens to celebrate ninety years of service to York County. These changes will lead us into our next century of service by illustrating our expertise in the classroom and the active role we take in shaping the early childhood education landscape in York County.





















ADVOCACY NEAR & FAR

Staff and families spent time in Harrisburg and Washington DC this year lobbying our legislators for increased support for high-quality early childhood education. We see firsthand how the high cost of childcare burdens both providers and families alike. In York County, 82% of eligible children under 5 do not have access to subsidized childcare, with the number rising to 86% for just infants and toddlers. Without increased public investment we will not be able to address this significant unmet need which is holding back our entire economy.



Family Engagement

We were so excited to bring back two of our favorite family engagement events this year! With the support of Wagman Construction, we hosted our annual spaghetti dinner in November and in collaboration with the PNC Mobile Learning Adventure, we hosted our Ice Cream Social in June. We love getting families and teachers from both centers together to enjoy the fun and fellowship that makes York Day so special.

was awarded from the York Day Nursery Infant-Toddler Scholarship Fund, supporting 35 children.


